



I Recommend CAA Tomato Bisque Soup Contest January 4 – March 31, 2012

Information is collected in accordance with Husky's Privacy Statement and will be retained for administration of this contest and for marketing purposes.

Contest Dates

"I Recommend CAA Tomato Bisque" Contest (also referred to as the "**Contest**") begins January 4, 2012 and closes at 6.00 a.m. (Mountain Standard Time) on March 31, 2012.

Who Can Enter

No purchase is required. Contest is open to all persons who reside in the province of British Columbia, Alberta, Saskatchewan, Manitoba and Ontario and are 18 years of age or older, except for retailers and agencies of the Canadian Automobile Association or for employees, retailers and agencies of Husky Energy and the immediate family members of such persons or people that reside in the same household.

How To Enter

To enter the Contest, individuals must visit a Husky House Restaurant and ask a Husky House Restaurant Server to fill out a ballot entry form which will be submitted on your behalf.

By allowing a Husky House Restaurant Server to fill out your name and CAA membership number on the electronic ballot form and submitting it on your behalf, you consent to Husky Oil Marketing Company ("**Husky Oil**") using this information for contest administration. Husky Oil will retain personal information only for as long as is necessary to fulfill the purposes for collecting such information. Husky Oil will not sell or redistribute personal information.

All entries received have an equal chance of winning. The chances of winning depend on the number of entries received. No purchase is necessary to enter this contest. All entries received on or before the Contest closing date will be entered into the draw. Prizes

There are eight (8) prizes to be won. Four (4) prizes will be awarded to the randomly selected eligible contest entrants in British Columbia, Alberta, Saskatchewan/Manitoba and Ontario and four (4) prizes will be awarded to the Husky House Restaurant servers who each provided service to the randomly selected eligible contest winners.

Each contest entrant prize will consist of 250 CAA Dollars® and each server prize will consist of a selection of gift cards totaling \$250.
